### Terms of Reference (TORs) for Hiring of Consultant Firm

**Hiring of Consultant Firm:** FGCC is going to execute a Project of Category "B" Building Phase III (3 floors including Basement). DWP meeting held on 25<sup>th</sup> January, 2019 in the Committee Room of Textile Division, Islamabad decided to hire the services of a qualified and experienced consultant firm for this purpose through prequalification process / advertisement.

**Eligibility Criteria for Consultant Firm:** The instructed consultant firm shall be a tax filer and registered with Pakistan Council of Architects and Town Planners (PCATP), and Pakistan Engineering Council, incorporated for at least ten (10) years for offering similar services and have completed ten (10) similar projects of this scale or above and complexity and in comparable organization. Consultant Firm should possess good knowledge of all concepts, principles and approach required for this assignment. The consultant firm should provide details (documentary evidences e.g contract award or reference letter from the clients starting scope of services and deliverable) of all such projects for the last 5 years or more during which they were completed. In case of joint venture, the details of such projects will be provided separately as primary or associated consultant firm. Shall have an adequately staffed and equipped offices with complete address. Shall have competence of existing and proposed personnel. Shall have sufficient management, survey work, data analysis, and report writing. Experience of working with Government would be an advantage.

**Short-listing of Consultant Firms:** Faisalabad Garment City Company shall determine criteria for short listing. There will normally be a minimum of three or more consultant firms in the shortlisting process. Any other factor that FGCC may deem relevant, not inconsistent with these regulations or Public Procurement Rules, 2004. All applicants shall be informed whether or not they have been short listed.

#### Terms & Conditions (Criteria / Documents) are required:-

Following documents / criteria is required for preliminary examination and selection of Consultant Firms are as under:-

- a) Pakistan Engineering Council Membership Number Certificate
- b) Pakistan Council of Architects and Town Planners (PCATP)
- c) Registration Certificate of NTN and PRA (active taxpayer)
- d) Number of Similar and Comparable projects for the last 5 years or more
- e) Declaration of ineligibility for corrupt and fraudulent practices issued by any Government (Federal, Provincial), a local body or a public sector organization etc.
- f) Affidavit on legal stamp paper of Rs. 100/- that their firm has not been blacklisted in the past on any ground by any Government (Federal, Provincial), a local body or a public sector organization.
- g) Complete profile of Firm along with Logistical & Staff capacity
- h) General experience, Specific experience and Past performance
- i) Overall Relevant Experience
- j) Experience proof of working with Government (which would be an advantage)
- k) Under PPRA rule-33(A) the procuring agency may reject all bids or proposals at any time prior to the acceptance of bid or proposal reason will be conveyed on formal request only.

**Selection Process:** The consultant firm will be selected in accordance with the criteria laid down in "Public Procurement Rule 2004" method set out in the "Regulation 2010 for Procuring of Consultancy Services" prescribed by the PPRA Rules.

#### **Deliverables:**

The selected Consultant Firm will deliver the followings:-

- Complete structural, Architectural, Plumbing, Sewerage, Water supply, Electrical, Mechanical, Fire Hydrant System etc. designs of the Project (Basement + Five stories) estimated area 135078 sft.
- ii. Detailed Bill of Quantities (BOQ,s) Technical specifications of civil works in the form of tender documents.
- iii. Engineer's estimates with rates and with reference to floors.
- iv. Details of tests to be performed for testing of materials before construction and after construction and during the construction.
- v. Any other drawings and designs related to the project.
- vi. Will provide two supervisors at the site if selected for the work / task.
