Sealed Bids are invited from interested well reputed Firms, Suppliers Firms and Venders etc. for supply of Equipment / material miscellaneous items for Day Care Center in Faisalabad Garment City Company (FGCC), Faisalabad as per following detail:-

a. Equipment / material ----- Detail of items can be obtained from the office of FGCC on or after 19th June, 2019, during office hours.

1. The bid shall comprise a single package containing two separate envelopes. Each envelop shall contain the financial proposal and the technical proposal separately;
2. Envelops shall be marked as "FINANCIAL PROPOSAL" and TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion.
3. Bidding documents containing BOQ.s, Eligibility Criteria & instructions to the prospective bidder can be obtained on 19th June, 2019 onward from FGCC office in Value Addition City, 1-1/2 K.M. Khurrianwala-Sahianwala Road, Khurrianwala Faisalabad during office hours from 9:00 am to 5:00 pm free of cost.
4. The amount of earnest money for the above bid is 2% (refundable) of total bid amount payable in the form of Bank Draft/Pay Order in favor of the Faisalabad Garment City Company.
5. The interested bidders / suppliers may submit their bid complete in all respect upto Wednesday, 3rd July, 2019 till 11:00 am and bids will be opened in the presence of their authorized representatives on the same day at 11:30 am.
6. Only those bidders are eligible to apply who have valid NTN No. and GST No. with attested copies of registration numbers as their profile duly issued by FBR / quarters concerned.
7. Organization structure of the contracting firm whether the firm is a partnership, public limited company or private Ltd. Company or etc.
8. Bidder will submit an undertaking on stamp paper that firm is not involved in litigation and have not been black listed by any Executing Agency, previously.
9. After preliminary examination short listed / declared qualified Bidders will provide the samples of material for final evaluation / selection.
10. Company will use the quality & cost method based formula for (technical & financial) evaluation where applicable.
11. FGCC reserves the right to reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The FGCC shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
12. The supply orders will be given on the basis of open competitive bidding.
